## GENERAL FINANCIAL INFORMATION

#### ATTENDANCE POLICY:

One music lesson/tutoring session excused absence (with 24-hour notice) will be given per semester. (The exception is Pine Tree Academy off campus activities such as field trips, however, students are responsible for giving a minimum of prior 24-hour notice.) Students will be charged for other "excused" absences at the discretion of the teacher. Students will not be charged for teacher absences. When possible, lessons due to teacher absences will be made up, otherwise student will not be billed. Teacher and student will arrange make-up time.

Tutoring session day (s) and time (s) are to be scheduled with the PTCA office.

Music lesson day (s) and time (s) are to be scheduled with the PTCA office.

Lessons/tutoring are not to begin until student is registered with the PTCA Director and the student has received financial clearance.

Missed ensembles and classes <u>cannot</u> be made up. <u>Students cannot start ensembles/classes until financial clearance has been received. Fees and tuition are non-refundable.</u>

#### BILLING INFORMATION FOR CLASSES AND ENSEMBLES:

Semester tuition and yearly registration fees for classes and ensembles are due in full at the time of registration.

### BILLING INFORMATION FOR MUSIC LESSONS AND TUTORING SESSIONS:

#### Payment Plan A:

Yearly family registration fee and current semester of music lessons/tutoring sessions paid at time of registration.

#### Payment Plan B:

Yearly family registration fee paid at time of registration. Students will be billed monthly for actual lessons. Accounts must be kept up-to-date. Accounts 60 days past due will result in the immediate cancellation of private lessons/tutoring sessions. Lessons/tutoring can resume when payments are current.

#### **DROP DEADLINES AND REFUNDS:**

One week notice is needed in order to drop music lessons and tutoring sessions. Notification of withdrawal, requests for refunds and any changes in status (i.e. changing length of music lesson/tutoring session) must be made to the PTCA Director.

Fees and tuition for classes and ensembles are non-refundable after the beginning of the semester.
